#### **First this:**

**ICC- UNSGAntonioGuterres- UNnations have started a Spacewar in a corrupt lobby.**

#### **Most likely Consequences:**

- From 2020 UNnations will use Laserweapons to pulverize satellites / devices in Space... = Act of War. All UNnations already lie to eachother about their hidden criminal acts in Space.
- On Earth this can result in total chaos: Humans are being confronted with fire-injuries caused by ICT-devices that stop operating or explode + Economy will fall still or burst into flames.
- Private Space-compagnies like Spacex & Hiberglobal participate in the design & conduct of these warcrimes, today in 2018.

#### **SpaceX, ElonMusk:**

- He ignores all his legal obligation, which are determined in the USA-constitution + UNcharter + Torture-treaty + Humanrighttreaties + <http://www.unoosa.org/oosa/en/ourwork/spacelaw/treaties.html>
- SpaceX hides all Business-partners with whom they close Business-contracts; refuse to prove to the people on Earth they SpaceX operates legally correct in accordance with InternationalLaw.
- SpaceX proves to me that they don't want to operate legally correct.
- I gave SpaceX, ElonMusk a copy of the ICCLawcaseNL, which also contains an ICCLawcase against President DonaldTrump for supporting DictatorshipNL-leaders with expanding this DNL in the hidden ICC-UN-Business lobby.
  - PresidentTrump :
    - ✗ owns the legal obligation to conduct all UNLaws & Treaties, with the aim to prevent DictatorshipNL from starting or to stop already started DictatorshipNL
    - ✗ owns the legal obligation to conduct all UNLaws & Treaties for te RESET of State of Law the Netherlands into a RepublicNL, in coöperation with UNSG AntonioGuterres
    - ✗ owns the legal obligation to make sure that Commercial Space-compagnies can not start a Spacewar while he looks away – being bussy ignoring all his UN-obligations –.
    - ✗ is obliged to make sure that FBI-director ChristopherWray & USA-Embassador Peter Hoekstra in Thehague Holland, can not start a Spacewar on their own initiative in ICCcorruption.

  - **DictatorTrump can scream in the media 'that the USA doesn't recognize ICC, but in the lobby he misuses ICC as cover for his warcrimes on Earth and for starting a hidden Spacewar'.**
- **SpaceX, ElonMusk plays an Evil Twitter-games with me.**
  - He refuses to write me +ICC +UN, a letter in which he determines: 'SpaceX will conduct the UNcharter + Torturetreaty + HRtreaties + all Spacelaw legally correct... And will assist DesireeStokkel with Cleaning up ICC –UN –Whitehouse = remove all warcrimes being conducted at the moment in DictatorshipNL + UNSG office + Whitehouse Office + FBI. SpaceX wil recognize RepublicNL founded on 18nov2016, officially in the UNSG-office and will only close Business-contracts in RepublicNL with Dutch compagnies.   - ElonMusk sent me a private Tweet with the question: How are you? And he answered 'Yeah' to my question: Do you come to Holland to talk about the ICC-courtcasefile and your Dutch Businesscontracts ---- and to go public with our relationship---? **He never did!** ElonMusk refused to make the effort to re-anchor SpaceX and his private legal

position in Justice – UNpeace – RepublicNL... for Spacewar-free Business-processes & Business-contracts.

- **On 3December2018, SpaceX ElonMusk willfully launched a satellite for the Dutch private compagny HiberGlobal, ErnstPeterHovinga...which is a warcrime on behalf of SpaceX.**
  - ElonMusk is – thanks to me – updated about the legal fact that HiberGlobal ignores ALL its legal obligations, as determined in the Constitution Kingdom NL + UNlaws & Treaties + Spacelaws + new Constitution for RepublicNL and its new RepublicNL legislation.
  - HiberGlobal = Pro-DictatorshipNL + Pro-Maffia = the RoyalFamily KingWillem-Alexander, QueenMaxima, MrPietervanVolenhoven... all support the Maffia and sabotage anti-Maffia. They make sure the InternationalCriminalCourt personnel is free to be warcriminals in co-work with UNSGAntonioGuterres- and all other UNdepartments, so the NL-members of parliament & NL-Judiciary judges are free to stay above the law too.

- **The legal fact that SpaceX ElonMusk operates as I prove here in this ICCcourtcasefile, is evidence for the fact that ElonMusk handles me as his Slave. - HiberGlobal tries to hide all Business-information for the people on Earth. Which is unacceptable now HiberGlobal pretends to realize the Fairtrade-world on Earth.
- Its a 100% Evil organisaton which also blocked Me on Twitter = I may not disturb their Happy DictatorshipNL celebration with Legal evidence that they willfully started a Spacewar – together with SpaceX – on 3December2018.
